WWTF – WTFAP grant of \$400,000.00 was awarded to the city to help defray the cost of the estimated \$1,100.000.00 compliance project on the current WWTF.

CDBG Community Development and Housing needs assessment - several items of needs were discussed including affordable housing, sidewalks and park shelter - restroom improvements.

Hometown Pride Program – local efforts going forward if the position is funded by the County cities will be asked to contribute \$300.00. The Council agreed the program was worth continuing.

A motion to approve resolution 2022-13 which is for the annual transfers to savings, economic development \$1,500.00, fire truck savings \$5,000.00 was made by Hicks with a second by Stankee. All ayes.

A motion to approve resolution 2022-14 which is for the transfer to road use checking from the tractor savings in the amount of \$30,000.00 was made by Stankee with a second by Grau. All ayes.

During discussion regarding a four – way stop sign at Main and Jefferson Streets it was decided that a 4-way stop would not be beneficial.
