Noise complaint regarding dogs at 308 N. Main St, Tami Laursen and Melanie Heiar were present to discuss concerns. Laursen presented a police report and emergency room report from the dog at 308 N. Main St attacking her. The dog is showing aggression each time someone walks past the home. They ask that the Council consider removal of the animal from the city due to history of aggression. A motion to notify the owner of the animal that it will have to be removed from city limits was made by Bousselot and a second by Wiese. All ayes.

A motion to remove the city owned trees at 302 E. Vine Street, 206 E. Jefferson St and at Wheatland Ag on Madison St street near the light pole was made by P. Stankee with a second by Wiese. All ayes.

A motion to approve the 5 year **road maintenance agreement** between IDOT and the City was made by P. Stankee with a second by Denahy. All ayes.

A motion to approve the **streets repair** bid for \$33,984.75 with LL Pelling was made by Bousselot with a second by P. Stankee. All ayes.

A motion to approve the street marking bid with Clinton County for \$1,220.56 was made by P. Stankee with a second by Bousselot. All ayes.

A motion to approve the **bridge inspection contract with Calhoun-Burns and Associates** for a maximum of \$10,000.00 was made by P. Stankee with a second by Weise. All ayes.

A motion to approve **resolution 2016-09** which is for setting employee wages for the 2017 fiscal year was made by P. Stankee with a second by Weise. All ayes.

A motion to approve the 3rd reading of **ordinance 169-16** which is for the water rate increase effective with the July 1, 2016 utility bills was made by P. Stankee with a second by Weise. All ayes.
