Wheatland City Council Proceedings June 13, 2016

Mayor Pro-tem Stankee called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members P. Stankee. Bousselot, Wiese, C. Stankee and Denahy present. Mayor Schnede was absent. Also present were city employees Jayson Cavey and Laurie Ganzer.

Ganzer noted that the abatement notice for 214 Main Street has been sent to the owners. The owners are given until August 31, 2016 to address the issues with the building.

Purchasing recycle bins was discussed. Ganzer was instructed to get prices for the type of containers we have now.

A motion to discontinue the **noon whistle** was made by Bousselot with a second by C. Stankee. All aves.

A motion to approve \$2,450.00 to Custom Art & Design to replace the **sign at City Hall and the one at the park** was made by C. Stankee with a second by Bousselot. All ayes.

The Clinton County Sheriff's Office spent 69.67 hours in the city of Wheatland from April 26, 2016 through May 25, 2016 while on patrol they issued 3 warnings, 6 citations, handled 1 incident and answered 13 calls.
