Butch Steines building permit will be issued once survey is complete and stakes are put in to assure proper set backs are followed. Hicks will follow up with Steines and inform the clerk when permit can be approved.

A motion to approve the **closing of Main Street at JR's place to Desperados** for a street dance on August 26th was made by Stankee with a second by Hicks. All ayes.

Resolution 2023 – 01 which is for the approval of the 2022 Streets Financial report was made by Stankee with a second by Grau. All ayes.

A motion to approve the second reading of **Ordinance 196-23** which is for a 3% water rate increase was made by Stankee with a second by Houzenga. All ayes.

A motion to approve Chelsea Petersen to a seat on the **Curtis Memorial Library Board** was made by Stankee with a second by Hicks. All ayes.

Reports – Cavey noted that the recycling truck may be ready for delivery by the end of August.

At 7:01 p.m. a motion to adjourn was made by Stankee with a second by Heileman. All ayes.
