# Wheatland City Council Proceedings December 8, 2014

Mayor pro-tem Stankee called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Woolard, Weise and Roman present. Rohling was absent. Also present were city employees Jayson Cavey and Laurie Ganzer.

A motion to approve the consent agenda was made by Woolard with a second by Weise. All ayes.

**Public forum** – no oral or written comments were made.

**402 Toronto Street abatement completion** – bids for demolition were submitted by Rohling Farms for \$5,800.00, Nesretep & JVH Excavating for \$8,000.00 and Dexter Dozing & Scraping for \$16,350.00. Todd Rohling was present to inform the council that he had been hired by the property owner to take the house down, remove the debris, supply fill dirt and plant grass seed in the spring. Rohling stated that the work will progress as weather provides. He intends to remove the house immediately after the owner removes some items from the home. Rohling estimated that the removal can begin sometime the week of December 15<sup>th</sup> but that it would depend on the homeowners ability to remove the items from the home. Rohling assured the council that the home will be removed this fall but that removal of the basement and fill will depend on temperatures. A motion to accept the solution provided by Todd Rohling was made by Woolard. Ayes – Stankee, Woolard, Roman. Abstain – Weise.

No date & time was set for the 2016 budget work shop. Budget review will take place at the January 12<sup>th</sup> meeting.
