

**Wheatland City Council Proceedings  
January 9, 2017**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members C. Stankee, Denahy, Wiese, P. Stankee and Boussetlot present. Also present were city employees Matt Cavey and Laurie Ganzer.
