

**Wheatland City Council Proceeding
January 14, 2019**

A motion to approve **resolution 2019-07** which is for the approval of a depository for city funds was made by P. Stankee with a second by Denahy. All ayes.

A motion to approve **resolution 2019-08** which is for designating a newspaper for city publications was made by C. Stankee with as second by Denahy. All ayes.

A motion to approve **resolution 2019-09** which is for approving the City Clerk to pay certain bills prior to a meeting to avoid late charges was made by Wiese with a second by C. Stankee. All ayes.

The remainder of the meeting was used to work on the 2020 budget.

At 7:37 p.m. a motion to adjourn was made by Denahy with a second by Wiese. All ayes.
