

**Wheatland City Council Proceedings
February 8, 2016**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members C. Stankee, Denahy, Weise, P. Stankee and Boussetot present. Also present were city employees Laurie Ganzer and Matt Cavey.

Fosbinder will prepare a contract for the March meeting for engineering services. Ganzer was instructed find funding options.

A motion to allow Eric Dau of **Clinton County 911 Communications system to investigate options for placing a repeater on the water tower** was made by P. Stankee with a second by Boussetot. All ayes.

At 6:53 p.m. a motion to open the public hearing for the 2017 budget was made by P. Stankee with a second by Wiese. All ayes.
No oral or written comments were made.

At 6:54 p.m. a motion to close the public hearing for the 2017 budget was made by C. Stankee with a second by Denahy. All ayes.

A motion to approve **resolution 2016-07** which is for the approval of the 2017 budget was made by P. Stankee with a second by Denahy. All ayes.

A motion to approve **resolution 2016-08** which is for establishing a general fund savings account was made by C. Stankee with a second by Wiese. All ayes.

A motion to renew the **contract with the Clinton County Sheriff's Office** at a cost of \$16,320.00 was made by P. Stankee with a second by C. Stankee. All ayes.

The **Clinton County Sheriff's Office** spent 68.25 hours in the city of Wheatland from December 26, 2015 through January 25, 2016 while on patrol they issued 2 warnings, 4 citations, handled 2 incidents and answered 6 calls.
