

**Wheatland City Council Proceedings
February 9, 2015**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Rohling, Stankee, Weise, Woolard and Roman present. Also present were city employees Laurie Ganzer and Jayson Cavey.

A motion to approve **resolution 2015-07** which is for the approval of the 2016 budget was made by Stankee with a second by Wiese. All ayes.

A motion to purchase a door replacement for the garage entrance at the library from Eastern Iowa Overhead Door for \$1,000.00 was made by Stankee with a second by Wiese. All ayes.

A motion to approve the City Clerk to attend the Clerk's Academy in Ames July 29-30, 2015 was made by Rohling with a second by Woolard. All ayes.

The **Clinton County Sheriff's Office** spent 63.73 hours in the city of Wheatland from December 26, 2014 through January 25, 2015 while on patrol they handled 5 incidents and answered 11 calls.

Reports – Fire Chief Steward was present to ask the council to consider a new tanker rather than a used one. Chief Steward explained that the members of the department voted to request a new truck. The cost of a refurbished truck would be approximate \$85,000.00 where a new truck would be \$120,000.00. The majority of the department felt a new truck with a warranty and fewer potential problems would be more beneficial. Chief Steward will obtain bids and bring them to the March meeting for consideration.
