

**Wheatland City Council Proceedings
February 13, 2017**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members P. Stankee, Boussetot, C. Stankee, Denahy and Wiese present. Also present were city employees Laurie Ganzer and Matt Cavey.

A motion to approve **resolution 2017-18** which is for the approval of the 2018 budget was made by P. Stankee with a second by Wiese. All ayes.

Vine Street bridge – culvert will replace bridge. Cavey will obtain bids from JJJ Enterprises for replacement and submit them at the March 13th meeting.

A motion to approve contacting MSA Professionals regarding repairs for the **Jefferson St bridge** was made by P. Stankee with a second by Wiese. All ayes.

Library carpet cleaner and Sam's Club membership – The Library Board can determine if the library needs a carpet shampooer from their budgeted funds. The City is not interested in a Sam's membership but encourages the library Board to determine if purchasing a membership for their facility would be beneficial.

Skid loader bids were tabled.

The **Clinton County Sheriff's Office** spent 73.28 hours in the City of Wheatland from December 26, 2016 through January 25, 2017 while on patrol they issued 1 warning, handled 4 incidents and answered 11 calls.
