May 11, 2009**

Mayor Bopp called the regular meeting of the Wheatland City Council to order at 6:30 p.m. at Wheatland City Hall with council members Patterson, Schnede and Rohling present. Prachar and Denahy were absent. Also present were city employees Matt Cavey and Laurie Ganzer.

A motion to approve the consent agenda was made by Rohling with a second by Schnede. All ayes.

The **Clinton County Sheriff's Department** spent 70.87 hours in the City of Wheatland from March 26, 2009 through April 25, 2009 while on patrol the issued 3 citations, handled 5 incidents and answered 9 calls.

Mat Saur of MSA Professionals was present to discuss the recent inspection report for the **waste water treatment facility** from the IDNR. Schnede made the motion to approve MSA to prepare a plan of action response by June 1, 2009 to demonstrate how the City will alleviate the high ammonia levels due to excess infiltration with a second by Patterson. All ayes. Smoke testing was discussed to determine if there is sump pumps hooked to the sewer system illegally or broken sewer lines on private property.

A motion to allow **JR's Place to close Jefferson Street** between JR's Building and the bank on June 6, 2009 and August 15, 2009 from 5 p.m. to 2 a.m. was made by Schnede with a second by Patterson. All ayes. The council reminded JR's Place that the band must quit playing by midnight.

A motion to approve **building permit 198** for Harry's Farm Tire was made by Schnede with a second by Rohling. All ayes.

A motion to approve Mike Weise to haul away the **concrete and clay at the compost pile** was made by Rohling with a second y Patterson. All ayes.

A motion to allow Main Street to be blocked off from the north side of Desperados to the south side of Dempsey's Pizza and Jefferson Street to be block from the West side of the Community Hall to the east side of JR's Place on **July 25, 2009** from 8 a.m. to Midnight for **Summerfest** was made by Rohling with a second by Patterson. All ayes.

Council member Denahy joined the meeting at 6:55 p.m.

During **public forum** Bob DeWys informed the council that the door to City Hall is scheduled to be replaced some time this week.

Mr. DeWys requested that the maintenance department lower the water shut off at his residence.

A motion to donate the \$300.00 recently received for a tobacco violation to the skate park committee was made by Schnede with a second by Denahy. All ayes.

A motion to approve **resolution 2009-18** which is for increasing the water rates by 5% beginning July 1, 2009 was made by Schnede with a second by Rohling. All ayes.

The City Hall sidewalk replacement specification was tabled.

A motion to deny **building permit 195** for 207 W. Lincolnway was made by Schnede with a second by Patterson. All ayes.

The sidewalk at 201 W. Lincolnway is complete. No further discussion is needed.

During **reports** Rohling inquired if JJJ enterprises could come and grade several alleys.

Rohling also noted that a tree is growing in the fence around the creek on Lincolnway and Toronto by Mac's Triangle she requested that the tree be removed.

Patterson discussed the need to slow down traffic on Toronto Street. Ganzer was instructed to make necessary arrangements to create 4-way stops at Lincolnway and Bennett, Lincolnway and Williams, Lincolnway and Wright and Park Road and Toronto.

Andrea Werner was present to inquire if the City would be receptive to allowing the ambulance put an addition on the north side of the fire station. The council informed Ms. Werner that they would be more than happy to work with the fire and ambulance.

A motion to adjourn at 7:23 p.m. was made by Rohling with a second by Patterson. All ayes.
