

**Wheatland City Council Proceedings  
May 11, 2015**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Rohling, Stankee, Wiese, Woolard and Roman present. Also present were city employees Laurie Ganzer and Matt Cavey.

At 6:33 p.m. a motion to close the public hearing for the 2015 budget amendment was made by Stankee with a second by Wiese. All ayes.

A motion to approve a **5K run Eagle Scout project** by Jonathan Kastantin on June 6<sup>th</sup> beginning at 10 a.m. and ending at approximately 12 p.m. was made by Rohling with a second by Wiese. All ayes. Fire Chief, Pat Steward noted that the Volunteer Fire Department will be working with Kastantin to control traffic during the run.

A motion to approve **JR's Place to close East Jefferson Street** between his building and the bank each Friday from 4p.m. to 2 a.m. beginning May 15<sup>th</sup> through October 30<sup>th</sup> with quiet time beginning at 12 a.m. was made by Stankee with a second by Wiese. All ayes.

Storm sewer/sewer at 201 W. Lincolnway was not discussed. At this time no problems have been found.

A motion to approve **resolution 2015-10** which is for approval of the 2015 budget amendment was made by Stankee with a second by Rohling. All ayes.

A motion to approve **resolution 2015-11** which is for approval to place the Library Board reduction of required board members question on the November 3<sup>rd</sup> ballot was made by Rohling with a second by Woolard. All ayes.

A motion to approve the Clinton County Engineers street painting bid for \$1,220.56 was made by Stankee with a second by Woolard. All ayes.

During discussion of the **building located at 214 S. Main Street** the owner of the building stated that the structure is sound at this time and no problems are anticipated.

The **Clinton County Sheriff's Office** spent 77.17 hours in the city of Wheatland from March 26, 2015 through April 25, 2015 while on patrol they issued 1 warning, handled 4 incidents and answered 23 calls.
