

**Wheatland City Council Proceedings
August 11, 2014**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Roman, Rohling and Weise present. Woolard and Stankee were absent. Also present were city employees Matt Cavey and Laurie Ganzer.

A motion to approve **resolution 2015-01** which is for the approval of the 2014 annual Streets Financial Report was made by Rohling with a second by Weise. All ayes.

A motion to approve **resolution 2015-02** which is for placing \$16,000.00 in city funds into CD savings was made by Rohling with a second by Roman. All ayes.

The **Clinton County Sheriff's Office** spent 54.18 hours in the city of Wheatland from June 26, 2014 through July 25, 2014 while on patrol they issued 1 citation, 1 warning, handled 1 incident and answered 8 calls.
