

**Wheatland City Council Proceedings  
September 9, 2013**

Mayor Noel called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Steele, Woolard & Rohling present. Stankee and Schnede were absent.

**Vacating the alley between 401 & 402 Toronto Street and Wheatland Grain Storage** was discussed. Ganzer informed the council that who would pay the legal fees needs to be decided. Ganzer was instructed to contact the landowners involved about the legal fees and report back at the next council meeting.

A motion to approve the **2<sup>nd</sup> reading of ordinance 164-14** which is for the legislative updates as pertaining to lien notifications for landlords was made by Rohling with a second by Stankee. All ayes.

A motion to **set trick or treat time** for October 31, 2013 from 5 pm to 7 pm was made by Stankee with a second by Woolard. All ayes.

Discussion was held regarding ATV's travelling on city streets.

A motion to add additional properties to the cleanup list that Rohling identified was made by Woolard with a second by Rohling. Ayes – Woolard, Stankee, Rohling. Nays – Steele.

A motion to approve sending letters to those on the **cleanup list** with weeds and grass issues allowing them 10 days to correct the problem and handle all other issues on the list on a case by case basis was made by Woolard with a second by Rohling. Ayes – Rohling, Woolard – Nays – Steele. Abstain – Stankee.

A motion to approve the **form prepared for cleanup notices** was made by Woolard with a second by Kathy . Ayes – Woolard, Stankee, Rohling. Nays – Steele.

The Clinton County Sherriff's report was not available at the time of the meeting.

A motion to adjourn at 7:45 p.m. was made by Stankee with a second by Rohling. All ayes.
