

**Wheatland City Council Proceedings
November 9, 2015**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Rohling, Stankee, Wiese, Denahy and Carver present. Also present were city employees Laurie Ganzer and Matt Cavey.

A motion to approve the **Clinton County Mutual Aide Agreement** was made by Stankee with a second by Rohling. All ayes.

A motion to approve the bid for the **door replacement at the Curtis Memorial Library** in the amount of \$2,280.00 from Pro Choice Construction was made by Stankee with a second by Wiese. All ayes.

A motion to approve the payment of the legal fee required to form a **Fire Association** was made by Wiese with a second by Carver. Ayes – Carver, Rohling, Denahy, Wiese. Abstain – Stankee.

The **Clinton County Sheriff's Office** spent 69.87 hours in the city of Wheatland from September 26, 2015 through October 25, 2015 while on patrol they issued 2 warnings, 2 citations, handled 5 incidents and answered 17 calls.
