

**Wheatland City Council Proceedings  
December 14, 2015**

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members P. Stankee, Rohling, Weise, Carver and Denahy present. Also present were city employees Matt Cavey, Laurie Ganzer, council members elect Boussetot and C. Stankee.
